**Kerjasama perpustakaan adalah dua atau lebih perpustakaan (biasanya memiliki kesamaan subjek/wilayah/organisasi/minat, atau kesamaan lainnya) menjalin kesepakatan dalam pemanfaatan bersama sumber daya informasi (resources sharing) guna mencapai tujuan bersama**

**Konsorsium: kerjasama yang mengatur sekelompok institusi dengan kebijakan berbagi sumber daya antar anggotanya. Ini adalah aliansi strategis dari beberapa lembaga yang memiliki kepentingan bersama.**





## **Consortia are:**

- Organisations formed by several institutions coming together
- With some kind of formal structure
- To do things which they would find difficult to do on their own

# New Paradigm in Library



- 1. Format Koleksi**  
**Perubahan dari format tradisional ke elektronik/digital**
- 2. Pengorganisasian Koleksi**  
**Traditional library ke Hybrid Library**
- 3. Sistem Informasi Perpustakaan**  
**Perkembangan TI yang maju pesat mempengaruhi pula perubahan layanan dan perubahan kompetensi Pustakawan**
- 4. Akses Informasi**  
**Dari datang langsung, sekarang bisa secara universal di akses melalui database (Dari ownership -> Akses)**
- 5. Pengguna Perpustakaan**  
**Tadinya terbatas pada anggota perpustakaan, kini lebih luas**

# Perubahan Layanan Perpustakaan -1

Sebelum Web	Sesudah Web
Memberikan <i>multi-entry service</i> atau pelayanan yang terpisah untuk pengadaan, pengolahan, transaksi peminjaman, referensi, dsb.	<b>Menyediakan <i>one-stop service: multi-functional librarians serving multi-tasking customers</i></b>
Mengumpulkan informasi dan pengetahuan (umumnya tercetak) secara lokal	<b>Mengkoleksi dan menyediakan akses ke informasi dan pengetahuan serta sumber-sumbernya yang tersebar di seluruh dunia, dalam multi-format dan <i>tacit</i></b>
Menjaga koleksi dan akses informasi dan pengetahuan	<b>Menambah nilai pada informasi dan pengetahuan (<i>adding value</i>)</b>

# Perubahan Layanan Perpustakaan -2

Sebelum Web	Sesudah Web
Melayani individu atau kelompok tanpa melihat potensi hubungannya dengan individu atau kelompok lain	<b>Melayani individu atau kelompok sebagai anggota jaringan</b>
Memberikan pelayanan di tempat ( <i>on site</i> ) dan sebatas jam pelayanan	<b>Memberikan pelayanan <i>on-line 24 jam</i></b>
<b>Manajemen informasi :</b> <b>memberikan pelayanan sebatas akses informasi dan pengetahuan</b>	<b>Manajemen pengetahuan:</b> memberikan pelayanan bervariasi dan dinamis meliputi seluruh siklus pengetahuan (mulai dari penciptaan, perekaman dan publikasi, penyebaran, penggunaan, dan penciptaan kembali, pengetahuan)
 <b>Memberikan pendidikan pemakai sebatas mengenai pemanfaatan perpustakaan (<i>library skills &amp; literacy</i>)</b>	<b>Meningkatkan <i>information skills &amp; literacy</i></b> sedemikian rupa sehingga pengguna dapat memanfaatkan ICT untuk mengakses dan memanfaatkan informasi secara kritis; serta merekam, mempublikasi atau <i>share</i> , pengetahuan dengan efisien.

# What is eIFL.net?

**eIFL.net** is a not-for-profit organisation registered in the Netherlands and operational from Italy; it is a global coalition of some 50 national library consortia in transition and developing countries. It **supports the building and sustaining of library consortia and negotiates and advocates for the wide availability of electronic information in member countries.**





# eIFL.net goals



unite purchasing power of a large number of institutions through **national library consortia**

- create and sustain a global infrastructure for central negotiations, administrative and technical support, educational services and issues pertaining to the provision of electronic content
- advocate for the needs of member consortia with information providers, policy makers, funding agencies, international fora
- provide a capacity building, knowledge and resource sharing network for member consortia

# Electronic commercial content

**Assessment of the electronic information needs of country consortia**

- Negotiations with providers of electronic information
- Central negotiations on behalf of all or a group of member countries
- Model license available for members to use





## What do eIFL.net consortia do?

- Joint acquisition of electronic resources
  - Joint education and training of users
    - Joint fund raising
  - Joint creation of and making accessible local electronic content
- Joint implementation of library and university automation.....
- **MAINLY:** sharing resources effectively



# Consortium building and management

## - eIFL.net activities -

- Global General Assembly

- Sharing of best practice and case studies
- Online resources [www.eifl.net](http://www.eifl.net) incl. manuals, guidelines, models
- Participation in national and international fora
- Start up grants for poor countries





# Institutional repositories

## - capturing local content -

- eIFL.net has from the beginning aimed to be a conduit for electronic content produced in member countries
- Assistance with the selection of and installation of tools
- Recent call for proposals from member consortia
- Pilots in a number of countries

# eIFL.net and its members



- **provide systems and services** that reduce access barriers
- **represent and advocate** for the interests of consortia in relevant fora
- **negotiate effectively** on behalf of all members to reduce cost of access to electronic information
- **provide support to creation and management** of consortia to sustain access to remote and local e-content



# **Ensuring consortia add value**

The consortium should

- Increase cooperation among members
- Reduce redundant efforts
- Build upon and expand the core competencies of members
- Decrease costs as more libraries participate
- Have costs for membership that are reasonable, predictable and sustainable

## CARLIGH

Consortium of Academic and Research Libraries  
in Ghana

- Established in 2004, 7 member libraries
- In 2011, 27 member libraries
- Governing structure - 3-tier
  - Appointed advisory Board
  - Governing Board (Representatives from institutions)
  - Elected Management Committee

## CARLIGH Funding

- Membership fees: Yes, used for running the Consortium and Workshops
- Funding model: Flat rate for Full members and half rate for Affiliate members



## CARLIGH Staff

- Staff: No full time staff now but 4 voluntary workers
- EIFL coordinators integration in consortia activities; report activities to the Chair of the Management Committee who informs the members or directly to members at our meetings

## CARLIGH Challenges

- Funding for e-resource subscription and capacity building activities
- Commitment of members & succession planning
- Limited number of subscriptions to databases
- Limited usage of resources
- Much reliance on institutional funding
- Lack of/poor internet connectivity- Polys & COE
